Impediment	Description
Licensing usage throughout the year due to clashes with other groups. We were not made aware that other groups have booked every 2 nd Wednesday of the month for the whole 12 months. If this was something we could have done, we would have.	We have had to shuffle dates around numerous times throughout the year due to securing a guest speaker and then not being able to get a license for the platform. Given some of our guest speakers do not even charge us the £50 fee, even when their "going rate" is many times over this, I find it ridiculous that we cannot secure a license for the webinar service. As I mentioned last year, as a Charity we could apply to Microsoft to get every single member of the volunteering staff a free license that would give us all email and Teams live usage.

We would actually like to see if there is more HQ involvement with the Branches. We do quite often feel like we are left to our own devices for the year. All events appear to be London centric and we do not feel like the North has anywhere near as much support.

Could we look at possibly having a groups member joining out committee meeting once a quarter to provide an update to the branch on HQ updates? I think people sometimes forget that we all also have day jobs, so whilst some of this information may be readily available, it is often more helpful to provide direct updates. This could be combined with providing membership numbers by region with data that we can utilise. We used to have access to a PowerBI report, but we can no longer access it.

Honorary Fellowship

Nominees will have made an outstanding contribution to the charitable objectives of the BCS over an extended period.

The BCS award Honorary Fellowship under Byelaw 8 of the BCS's Royal Charter and Trustee Board Regulation 1.3 specifies that the BCS award may also make the award to non-members who may not be eligible for any other class of membership.

Community Board and Trustee Board will consider a candidate for Honorary Fellowship against the following criteria:

- At any time, both the contribution to BCS's work and the stature of the individual nominated should be commensurate with the standards set by previous recipients. There is no overall limit to the number of Honorary Fellows although it is unlikely that there will be more than two Honorary Fellows elected in any one year.
- To be elected, the nomination must be on the Trustee Board Agenda, and at least 3/4 of those present must resolve in favour.
