Report at 30 October 2018:

Please find attached the spreadsheet of the membership of ELITE as at yesterday. Since the last report the BCS has appointed 5 new Fellows, only one of whom has joined ELITE, but we received applications from 4 established Fellows and 2 additional people (non-FBCS) were nominated by the committee. There are now 3391 ELITE members and 1629 members of ELITE on LinkedIn. As was reported last week Mandy is now the owner of the LinkedIn group and I am the only manager. Continued ...

Review at the end of the 6-month trial:

• Although we have been unable to test applications from non-Fellows there have otherwise been no problems reported to me since the GDPR process was introduced on 30 April 2018.

Advantages of the new scheme:

- The process is compliant with GDPR and so the risk of the BCS being the subject of an action brought by a member/other party is reduced.
- The committee or its members cannot be held responsible for any claims brought concerning loss of data, privacy, bias, etc.

Disadvantages:

- There is a lack of transparency, i.e. we have to trust that the process is being applied correctly.
- There is a lack of information about who is joining ELITE.
- There are discrepancies between how we position ELITE on the BCS website and the words used in HQ correspondence to new Fellows (see para 2 of the letter).

Recommendations:

- We should undertake a review of the process with HQ with a view to addressing the disadvantages and discrepancies.
- Members only become visible to us if they join LinkedIn, attend meetings, or engage with us in some other way so we must explore ways of improving member engagement. Since this now has the approval of HQ, I suggest we draft an email to be sent to all members of ELITE inviting them to join the LinkedIn group emphasising that it is the official group which is now

owned by the BCS. Please send your suggestions for other ideas for member engagement and I will compile them and report back to the committee.

5. Treasurer's Report

(Chris P - mailed in his report)

- Budget is as per last meeting i.e. much less than requested
- We have had one invoice since for an event in London
- There is a rebate of £115 from last year, which we need to apply for and spend soon
- Requested monies for the North/Midlands events are still well beyond what is possible with the reduced budget
- An end of year position is available

6. 2018 Elections (Jacqui)

(Jacqui provided an update from Chris T.)

Same number applied as we have vacancies.

Jeremy Acklam , Haiyan Wu (currently co-opted) and Ibukun Emmanuel (former committee member) have been formally elected to the committee for a 3 year term.

Three people did not submit a complete application: John Hall and Dalim Basu (both current committee members), and Stephen Allott.

ACTION: As we have sufficient vacancies, JACQUI will propose at the next committee meeting that we co-opt all 3 onto the committee until the next AGM in 2019

8. AOB
