



What is Chartered Management Consultant?

- CMI appointed by the Privy Council as the Awarding Body
- > Developed in partnership with the MCA
- Professional recognition of a consistent, high standard of professional development and achievement
- > Aligned to an industry-wide competency framework
- Value adding, self-reflective assessment, based on real hands on practice and experience
- > Cabinet Office representatives sit on the ChMC Oversight Board

Competency Framework



- Developed in consultation with many firms (e.g. PWC, EY, Deloitte, IBM, KPMG, BAE, PPL, GoBeyond etc)
- Details all the competencies required of a professional management consultant across a range of areas and reflects best practice for the consulting industry

- Qualification: for those who do not have an in-house accredited development programme, or the experience required for the Experienced Professional route, the Level 7 Professional Consulting Extended Diploma provides an alternative route to ChMC award
