

# BCS London (South) Branch AGM

## Present

10 people were physically present, plus 10 online. Apologies were not received.

## 1. Welcome – Jim Mclean, Chair

*I have written a Chairman's Report using the BCS template, of which I will pick out a few highlights.*

*Hopefully, live events will be the primary activity of the branch for the foreseeable future.*

*The BCS is in a process of transformation to meet its goal of "Making IT Good for Society". This affects member groups (branches and specialist groups) fundamentally.*

*There were only six or so meetings in the past year – in a more normal year it would be nearer 10.*

*The branch also awards student prizes once a year to Kingston University and NESOCOT. This is a cash award of £150 and free BCS membership for a year to the winner. It also gives the BCS valuable exposure, encourages graduates to join the BCS, and keeps the branch involved with the education sector.*

Chris presented the financial report, which had been circulated in advance. The expenditure was under budget thanks to the fact that all meetings had been online.
