Honorary Treasurer's Report Financial Year 2024/25

I am pleased to present the Honorary Treasurer's Report for the London Central Branch for the financial year 2024-25, this being September 2024 through August 2025. This report is presented at the Branch's Annual General Meeting on a date to be confirmed and it contains information correct as at Sunday 30th November 2025.

Financial Year 2024/25

To fund our operations during this period, we submitted a budget request which was reduced to £2052 which included no provision for student prizes. Under the chairman's leadership budgets were once again also agreed for London South and North and these were used in part to fund shared events. The information below relates only to London Central.' During this further hybrid financial year, the branch spent £2961, despite sharing event costs with the two other London branches because we ran an extensive programme of webinars and events that kept the membership engaged, active and entertained. We had only £145 (budget £570) speaker expense claims (mainly thanks to the generosity of our speakers and continued use of Zoom etc.). The significant overspend was on catering at £2516 (Budget £1140) but this was more than offset by new unbudgeted income sources including a donation from Westway trust of £1500 and Eventbrite registration fees for paid events totalling £1027. Eventbrite charges absorbed £224 of this income.

For the forthcoming financial year 2025/26, being September 2025 through August 2026 we prepared a full budget submission but instead received an email notification from head office.

Member Group Budget 2024/25 and 2025/26 Summary

The 2024/25 BCS financial year is coming to a close on 31 August, and we expect to have the final end-of-year accounts in mid-September.

We are anticipating ending the financial year at 90% of the member group budget. With an increase in sponsorship and event charging income, member groups will end the year above projected income.

The total member group funding allocation in the 2025/26 budget will remain at the same level. With fluctuations against individual groups depending on their individual circumstances, for instance, regular underspending or identification of increased impact supporting strategic goals.

We thank all of our treasurers for their role in ensuring this budget performance and recognise the commitment made by each of you in this active voluntary role.
