1. Chairs report (David)

- 1.1. The minutes of the last meeting (9 May 2023) were accepted as accurately reflecting the discussions of the committee meeting on 9 May and can now be found on Basecamp.
- 1.2. Seven committee members attended via Teams including the Chair and so the meeting was declared quorate.
- 1.3. Shakeeb's Meritorious Service Award was presented to him after the last meeting and he thanked the committee for his nomination.
- 1.4. The Nurturing Leaderpreneurs Paper is complete so, again, well done to Shakeeb and his team especially Stephen Castell and Colin German. See Communications below for how we can all help to promote this more widely.
- 1.5. IT Leaders conference 2023. HQ informed me that they now intend to run a separate event for corporate members hence we can proceed to organise the 2023 and 2024 conference programmes. The 2023 conference will be held in September and we are considering a Resilience, Ransomware and Cyber Crime theme. The committee was asked to consider ideas for the 2024 conference which will revert to Q1.
- 1.6. We are now adding internal and external collaborations to the diversifying range of ITLF member activities. Further collaborations are being planned with the Consultancy SG, Police Special Operations, and the Quality SG (this last one as part of the activity of the Service Resilience working group). It is possible that these collaborations will give rise to further working groups and opinion pieces.
- 1.7. HQ has established a community support committee and it is conducting a survey. They would like all member group committee members to participate in the survey in order that it can be as representative as possible of our thoughts. - 1.8. The cancelled CCI event. It has always been our aim to "provide a pressure-free, non-commercial setting for networking, problem solving, and discussion" so the decision of the UK Board of CCI to not restrict their paying sponsors in any way was unacceptable. They also wished to survey our members without assurances as to how the member data was to be used. Again, this was unacceptable and in the same month Meta was fined Eur1.2 Bn for a similar offence. We all belong to other organisations but, please, if you think that you may have a conflict of interest, please bring it to the attention of the committee.
- 1.9. To end on a positive note: a member recently posted the following on our LinkedIn Group, "I am heartened that this forum has grown into a true place to articulate views and exchange good practice. Despite the advertisement posts and the occasional less than helpful post; I believe that it is achieving its broader aims. I'd like to thank everyone who has kept the forum pure as a place to exchange views and experience. Catching up on posts during the last few months has made me proud that I'm a member of the IT community, and the British Computing Society."

2. Fellows Group

Sonia Patel has received our feedback re ideas for further discussions on improving the Fellow experience but we have not received a reply. A further suggestion offered was for the BCS to consider a Fellows badge similar to those given to members of the Worshipful Company of Information Technologists. ACTION: DM to pass this information on to Sonia.

During the discussion of the latest membership numbers, it was noted that about 10% of our members are "Overseas". Since ITLF members are senior in the profession, it was said that we might leverage these people and the concept of virtual events perhaps drawing on existing material to seek to develop the overseas membership. This would serve to both improve the UK's standing in a post-BREXIT world, and also expand membership in countries with young and fast-growing work forces. ACTION: Gill to create an initial draft plan for discussion.

4. Budget

In Gordon's absence, David reported that the latest budget update showed that we were underspent by £784.

5. Inclusion Norman.

Norman and Chris had obtained a proposal from Fearless Futures whose work was well known and highly regarded. There were some minor issues that could be overcome but the cost was

£2900 + VAT which was beyond our reach. Clients were typically large enterprises and so they were applying this business model to the BCS. ACTION: Norman and Chris to go back to the company to see if something more modest could be developed for our members, and if not to look for an alternative solution.

6. Working Groups

6.1. Service Resilience.

Gill's full report is in Basecamp but she was asked if she was happy with the way it was proceeding. There are four streams of work at the moment and the plan is that these will be handed over to other interested parties during this current phase.

6.2. Other Working Groups.

Matthew Taylor (Early Career Leadership and Mentoring), Jonathan Leeson (Future CEO), and John Hall (IT Leadership Courses for Higher Education) did not attend. ACTION: David to contact each of them for an update.

7. Events Q3 and Q4

- 7.1. September: conference. ACTION: David to liaise with all parties to fix a date and details.
- 7.2. 17 October: Service Resilience working group.
- 7.3. 16 November: Consultancy SG and ITLF collaboration hybrid event: "How do we plan a career in leadership through consulting?" (a panel discussion exploring the cycle between consultancy and leadership). The panel will consist of 4 ITLF members and one Consultancy SG committee member. ACTION: David to finalise the arrangements.

- 8.1. The IT Leaderpreneurs working group paper is live on our web site and it will feature in the November edition of ITNOW.
