

Faculty of Health and Care Board Treasurer

Brief

The BCS Faculty of Health and Care has recently been established to create a vibrant community of practice to support the professional development of all those working in digital¹ health and care and to provide an authoritative voice on behalf of the profession. The Faculty is governed by the Faculty of Health and Care Board (FHCB), which reports to the Community Board.

The Treasurer looks after the Faculty of Health and Care Board's finances – submitting budget proposals, requests for additional funding, and ensuring the group stays within their planned budget.

They also help the Chair in making sure the group is using their funds to make IT good for society through the four BCS strategic pillars; growing the membership of the group, inspiring others through events and activities, helping IT professionals at all levels to progress in and develop their career, and influencing society by working with the BCS Policy team.

Key responsibilities and Actions

- Prepares annual budget and potential project funding each year.
- Prepares or advises on requests for additional funding submitted in year.
- Responsibility to the FHCB for management of Faculty funds and any other appropriate financial business. This includes the management of any additional income and rollover funding (such as from the BMJ HCI Journal).
- Reports at fixed intervals to FHCB.
- Submits income and expenditure statements produced by BCS Finance to the FHCB annually.
- Deals with payments and receipts to and from the operational budget and liaises with BCS HQ staff as necessary.
- Notifies, through the Community Team (groups@bcs.uk), any forecast overspend together with (a) circumstances leading to this position and (b) proposed action plan to resolve the situation.

Commitment

We expect that the role holder will attend FHCB meetings at least on a quarterly basis to provide a financial report. In addition to this we expect that the holder to be responsible for the completion of tasks that fall within the key responsibilities laid out above
