FEDIP job role profiles update – Clinical informatics and data roles

BCS has been working with FEDIP to develop standard job role profiles, with work now completed on digital roles (based on the Government Digital and Data Framework) and information governance roles. These are being uploaded onto the [FEDIP website](#).

NHS Wales is leading on the development of clinical informatics job roles, such as chief nursing information officer, AHP informatics officer, clinical safety officer, etc., with a multi-disciplinary working group and representation from the four nations. The aim as, with all the role profiles, is to improve consistency and help ensure appropriate grading of roles.

Data roles are being developed in conjunction with NHS England/Analyst X/AphA and draw on the recently published National Competency Framework for Data Professionals.

The BCS RoleModel*plus* tool is being used to develop the role profiles and they are available to NHS users of RoleModel*plus* to use in their organisation to support workforce planning.
