Previous Annual General Meeting Minutes

The British Computer Society – London Central Branch

8th December 2022 at 6.30pm

Location: Hybrid – BCS London Office & Zoom

It was noted that there were 19 members in attendance.

1. Apologies for absence

2. Minutes of the AGM held on 11th November 2021

The minutes were approved.

3. Chair's Report

Mr Basu presented the Chair's report. It was noted that we had several event initiatives in the past year, all with the goal of supporting BCS' objectives of making IT good for society.

Mr Basu outlined the increased collaboration between other branches and specialist groups across BCS. Wherever possible we like to collaborate with other groups to increase the number of attendees and expose our events to a wider audience.

Mr Basu advised that he has taken on the role of Chair for the London South Branch in addition to Central & North and that going forwards we will be closely co-ordinating the activities of 3 of the 4 London branches.

The Chair's report was accepted.

4. Hon. Secretary's Report

Mr Grundy presented the Secretary's report. It was noted that we had an increase to 37 events in the past year and resumed hybrid and in-person events. Our most successful event was "Business Analysis in the Brave New World" which was a presentation by committee member Kitty Hung. Several other events had more than 100 participants as well.

The Secretary's report was accepted.

5. Hon. Treasurer's Report

Mr Lewis presented the Treasurer's report. It was noted that we began spending money again now that in-person events have resumed and most of the expenditure was on event catering.

Mr Lewis presented our approved budget for the coming year, which has been significantly reduced to £1,554. This is because BCS have changed their policies to try to reduce underspending of the allocated budgets. Mr Lewis noted that we have the option of submitting a Supplementary Expenditure Request should it be required, and that BCS will be redistributing funds between groups to the groups that will actively use the funds.

The Treasurer's report was accepted.

Chair's Report for the Year 2022/23

Whoosh!

How are you coping with the rollercoaster ride of IT advances in the 2020s? As we race away from the nightmares of the pandemic and lockdown, we no longer have the SPEED of tech change – it's now an 'ACCELERATION of change'.

For our BCS London Branches, in our key role in The Chartered Institute for IT and our shared aim of "making IT good for Society", it's been a very busy year. I hope that you have helped and learnt from our initiatives examining key issues and choices.

We increased our reach, planning and delivery of IT-related topics for the benefit of BCS members and others. Our product and service delivery activities have included more topics, speakers, deliverables, use of BCS facilities and products (including communications, AV, venue, books and publications).

We increased focus on events involving great speakers from large/medium/small organisations, many of whom have become great supporters of BCS.

We ran over 40 events in the past year. Events are listed in our Honorary Secretary's Report. Events were delivered in up to three formats – 'in-person', 'hybrid' and especially by live webinar. Video recordings of events were edited and made available faster to wider audiences via YouTube and Branch channels.

We increased our range of initiatives involving our great committees of enthusiastic volunteers and showcasing their skills and interests.

We also grew our own communities. Until October 2022 we comprised two Branches – Central and North London Branches (the CeNLB community). In October we welcomed the active collaboration of the London South Branch, and are working together as the 'London Branches 3' community, with the ability to reach over 10,000 BCS members, as well as other groups and external organisations. A huge range of IT-related experience, capabilities, innovation and entrepreneurship.

Then with BCS encouragement we rebranded again, and are now the BCS London Branches community, serving the above three London Branches and associated with a small but growing number of Specialist Groups.

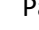

Catering

We continue to provide food and drink at our events to facilitate networking. This year we moved away from sandwiches and changed to ordering pizza, which has been well received by guests and provides better value for the charity thus allowing us to run more events within our budget. The catering expenditure is our primary expenditure. We have been catering to vegan and vegetarian options. So far we haven't catered for gluten free but this is something we have recently started being asked about, so we are considering the best options.

Social Media

We continue to upload recordings of the majority of our events to YouTube.

Number of new videos: 33

Number of views: 3,600+

Our most watched video was "The Cloud Series - part 1: What is cloud anyway?" which has more than 420 views. The event was in collaboration with the BCS Fellows Technical Advisory Group (F-TAG).

We've been maintaining a social media presence on LinkedIn and X but the impact remains somewhat flat. Our LinkedIn group now has 281 members and we regularly post event flyers there. Most of our event attendance continues to be driven by our BCS mailing list, BCS events website and Eventbrite with social media only making a very small contribution.

Diversity and Inclusion

I am also the branch's Inclusion Officer. We have a diverse committee with members having various backgrounds and interests so our events naturally reflect that diversity. In the last year we had 3 specific diversity and inclusion related streams which stood out:

- **Seniors**
We hosted seniors at the BCS London office to have tea and discuss tech and some of these sessions were in collaboration with Age UK.
- **Wominspiration**
This is a particularly large stream of events in which we interview inspiring women and find out about their career journey, benefiting from their useful insights and advice.
- **Passport to Success**
This is a new series where we interview guests who have had remarkable journeys in international migration and who have gone on to achieve success in the technological world.

We have also collaborated on diversity and inclusion related events with several BCS specialist groups and benefit from their expertise.

In May we attended a Diverse CXO event where CXOs gave mentorship and advice to people early in their career. In August we were invited to attend Black Tech Day by the organisers. We made some new contacts there and one of them became a speaker.

Honorary Treasurer’s Report Financial Year 2022/23

I am pleased to present the Honorary Treasurer’s Report for the London Central Branch for the financial year 2022-23, this being September 2022 through August 2023. This report is presented at the Branch’s Annual General Meeting on Monday 4th December 2023 and it contains information correct as at Monday 20th November 2023.

Financial Year 2022/23

To fund our operations during this period, we submitted a budget request which was reduced to £1554 which included no provision for student prizes. It represented a further major cut with no explanation from head office’ During this further hybrid financial year, the branch spent just £1200, despite running an extensive programme of webinars and events that kept the membership engaged, active and entertained. We had no speaker expense claims (mainly thanks to the generosity of our speakers and continued use of Zoom etc.),

Financial Year 2023/24
